The Working Group participants started the process by reviewing the entire Draft Relocation Plan (Plan). During this review, all questions were noted. After the review was complete, HVCP, the City Partners and the Consultants provided responses to the questions (which are attached) and revised the Plan as appropriate.

A revised Relocation Plan has been provided to HVTA (for distribution to the Working Group). The Working Group will now work with Bay Area Legal Aid and provide final comments on the Plan by October 22<sup>nd</sup>. This final Plan will be mailed to all Hunters View residents on October 24<sup>th</sup> and a full resident meeting will be held on October 28<sup>th</sup> at 5:30 PM at the HVTA office to present the Plan. Prior to the resident meeting, Working Group members will conduct outreach to other Hunters View residents to provide information and answer questions related to the Plan. Hunters View residents and the general public will have a 30 day comment period to submit any additional comments on the Plan and the Plan will then be finalized on November 26<sup>th</sup>, 2008.
